# EGB Societal Challenges Report 2023

#### Introduction

The main purpose of the EGB Societal Challenges Report 2023 is to make EGB's relevance to society visible to our stakeholders. This is in line with CBS' wish to contribute to solving grand societal challenges and to make research contributions and impact more visible.

EGB Scholars research two principal focus areas; International Business and Business & Government, and our area- and region-specific expertise allows us to address challenges faced by emerging and advanced economies.

While societal challenges are inherently changing and dynamic, at present, research at the department resonates with six societal challenges in particular:

- 1. Business and democracy
- 2. Technological change and digital transformation
- 3. Regulating societal challenges
- 4. The ethical MNE
- 5. Emerging markets and rise of Asia
- 6. Business, global shifts and policy changes

These thematic areas inform our research and funding activities, our dissemination activities, and serve as a point of departure for discussions with other departments on potential cross-cutting initiatives at CBS. We attempt to address the call from CBS senior management to be curious and transformative. The clusters seek to address new questions and we seek to be relevant to society, and visible to our stakeholders.

The six research clusters allow EGB scholars across research disciplines to meet and discuss their work. Through the clusters, we seek academic impact via publications and presentations at conferences and workshops, as well as societal impact and engagement with our stakeholders.

The report includes input from the 6 clusters, respectively, and ends with a section of individual contributions carried out outside the clusters.

The 2023 report covers 2022 activities in the respective clusters. The individual cluster reports reveal different activity levels and ways of working in the groups, reflecting that the cluster formation started in 2021 as an experiment without formal rules or guidelines. The clusters are now working on consolidating their activities.

# **Business & Democracy**

#### **Theme**

Research on Business and Democracy advances our understanding of challenges facing democratic and non-democratic governments. Research within this theme draws upon theory and methods in political science, political economy, and international business to explore the ways in which democratic and non-democratic governments influence – and are shaped by – the public, businesses, markets, and public policy at the domestic and international level. Current and future research focuses on a number of related issues: (1) The firm in politics and the role of money in politics, including firms' non-market strategies, political connections, and corruption, and the role of political and economic elites; (2) political risk and the role of the political environment for the investments and strategies of multinational corporations; (3) redistributive and regulatory politics, including the importance of democracy and state capacity for voters, firms, and markets; (4) social data science and its use for studying challenges to democracy; (5) government responses to economic and societal crises, including the rise of anti-globalization sentiments, violent conflict, and FDI.

#### **Conferences**

Two conferences organized at EGB should be highlighted.

#### Money in Politics Conference

In June 2022, the first Copenhagen Money in Politics conference at EGB was held. The conference was organized by Mogens Justesen and Benjamin Egerod and funded by the Danish Ministry of Higher Education and Science. Several other members of the Business & Democracy group participated as discussants and presenters at the conference. The conference was a great success, with over 40 participants from top international universities. Holding the Money in Politics conference at EGB has greatly increased the visibility of the department in this area. A second conference will be held in June of 2023. This year the organizing committee consists of Benjamin Egerod, Florian Hollenbach, Anne Jamison, Mogens Justesen, Michael Mueller, and Jan Stuckatz.

# Regional Inequality and Political Discontent in Europe

Mads Dagnis Jensen organized a conference held on October 13-14, funded by the Carlsberg Foundation. The workshop was to prepare a special issue of the Journal of European Public Policy entitled "Regional Inequality and Political Discontent in Europe." Anders Ejrnæs (Roskilde University), Dominik Schraff, (University of Aalborg), and Sofia Vasilopoulou (King's College London) were co-organizers.

#### **Work-in-progress seminars**

In addition to the money in politics conference, Benjamin Egerod organized the money in politics speaker series, which was funded by the Carlsberg Foundation. The visits were organized as all-day workshops with presentations by many of the theme's members. Each workshop typically included around four presentations of work-in-progress by EGB members, mostly from the Business & Democracy group. These workshops were held in April, May, August, and December 2022 and featured keynotes by Benjamin Barber (IE Madrid), Hye Young Yu (NYU), Alex Fouirnaies (University of Chicago), and In Song Kim (MIT).

Due to the speaker series, regular Business & Democracy theme meetings were not held in 2022, these are planned to resume in January 2023. The cluster is planning to hold monthly meetings for discussion of projects in the very early stages.

## **Grant Activity**

The cluster has been active in applying for grants and has had a few successes in the past year. David Fortunato, Zoltan Fazekas, Florian Hollenbach, Jan Stuckatz, and Mogens Justesen have all applied for different grants, including DFF-1 Projects and grants at the Carlsberg Foundation.

Mogens Justesen and Benjamin Egerod received funding for their project "Tycoon Candidates: Why Wealthy Business Candidates Get Elected for Office and How it Matters" from the Independent Research Council of Denmark as a DFF-2 project.

Mogens Justesen and Jan Stuckatz won a Research Excellence Grant from the University of Texas Austin, McCombs School of Business. Anne Jamison has won a number of research funding awards, including from Amazon, Ernst & Young, and the InterAmerican Development bank.

#### **Public outreach**

A number of our members have been actively involved in public outreach this past year. In addition to presentations at various conferences by many members, we want to highlight a few particular outreach activities. Jan Stuckatz has been selected as a Stigler Affiliate Fellow at the University of Chicago (joining Benjamin Egerod in that honor). In that capacity, he presented his research in Chicago in September 2022.

Benjamin Egerod has been interviewed by multiple media outlets throughout the year 2022 (total of 12 interviews) and published an op-ed in *Information* in December.

Florian Hollenbach is continuing his work as part of the anti-corruption data collective and recently attended a meeting with practitioners and NGOs at the international anti-corruption conference (IACC) in Washington, D.C. Part of the research on money laundering in real estate has been presented to NGOs, the British government, and at the World Bank's Symposium on Data Analytics and Anticorruption.

# Example of public outreach and impact:

# ADCD - Fighting corruption and money laundering

Florian Hollenbach is one of the primary academic researchers and an executive committee member at the Anti-Corruption Data Collective (ACDC) (https://acdatacollective.org/). The goal of the data collective is to bring together leading journalists, data analysts, academics and policy advocates in an effort to expose transnational corruption flows and push for policy change using the advocacy reach of ACDC partners.

One of the primary areas of interest in 2022 and beyond is corruption and money laundering in real estate. One major research project in 2022 was evaluating the impact of new transparency regulations in the US on real estate markets. In January 2016, in response to the threat that money laundering poses to the real estate sector, the US Financial Crimes Enforcement Network (FinCEN) announced it would introduce a real estate Geographic Targeting Order (GTO) program in both Miami-Dade and Manhattan counties. This program required that for companies purchasing residential properties information on the ultimate beneficial owner would have to be collected for cash purchases above a certain price. The policy was later expanded to other counties and lower price thresholds, covering a large proportion of the residential US real estate market. In our research paper, we evaluate the effects of this policy on residential real estate transactions in the United States. We find little evidence of any sustained effects, raising questions about the effectiveness of the policy. The resulting research paper "The Impact of Beneficial Ownership Transparency on Illicit Purchases of U.S. Property" has been used to inform policy makers and bureaucrats in the US. For example, it informed a public commentary made by ACDC to the US Department of Treasury's Financial Crimes Enforcement Network (FinCEN). # **Regulating Societal Challenges**

#### Theme

Increasingly, societal challenges have a cross-border dimension, making it more complex for governments to regulate, and for businesses and other societal stakeholders, to shape agendas. Furthermore, issues with a transnational dimension are coordinated at international and EU levels, although most regulatory authority remains in national contexts. The challenges include climate change, the automation of work, migration, discrimination in organizations, disaster management, and the politics of fiscal governance in the EU and beyond. Although regulation is important to mitigate the worst effects of these challenges, problems in policy design may in fact entrench or worsen these effects. Therefore, it is just as important to pay attention to both policy design and policy effects.

The scholars in this group publish in a variety of high-quality social science outlets, focusing among other issues on politics, regulation and international business. There are various externally financed projects within this theme. This includes the Nordforsk-funded Reimagining Norden in an Evolving World (ReNEW) project, focusing on governance of grand challenges in the Nordics, and the EU Horizon project, EUSocialCit, focusing on governing social rights in the EU context. Another project within this cluster, financed by the Swedish Research Council, is entitled "Exploring Hiring discrimination and possibilities for intervention with eye-tracking".

# Example of publication:

# Governments' Responses to the Covid-19 Pandemic in Europe

European countries were hard hit by the COVID-19 pandemic in early 2020. It swept throughout the continent in the spring, scaring citizens as the media reported on struggling healthcare systems and the failure of public procurement authorities to stock up on necessary supplies. Different attempts to govern social interactions throughout the following 15-18 months described in this book provided a stress test for political systems across Europe, and their answers displayed both commonalities and fundamental differences. This book compares and contrasts the ways in which 31 European governments handled the COVID-19 outbreak.

Caroline de la Porte presented findings from her recent collaborative research on the theme of *Regulatory challenges with the EU's work-life balance directive*. The public seminar included stakeholders, academics, students and policy-makers as part of the EUSocialCit research project.

Faith Hatani spoke on *The green transition in the automotive industry*, focusing on the interactions between government policies and firms' strategies in the contexts of Japan and South Korea, at the Global Conference on National Competitiveness and Nation Brands 2022, organised by the United Nations Institute for Training and Research (UNITAR).

Torben Juul Andersen has contributed to the UNDP GAR-2022 (Global Assessment Report on Disaster Risk Reduction) proposing a model (space-form) where public, private, and plural organizations collaborate on sustainable solutions to advance circular economy and reduce carbon emissions.

# DO ENVIRONMENTAL POLICIES AFFECT MNES' FOREIGN SUBSIDIARY INVESTMENTS? AN EMPIRICAL INVESTIGATION

Reducing greenhouse gas emissions to help tackle humanity's greatest challenge – reversing climate change is a defining issue of our time and a key focus of many individuals, firms, and governments.

To reduce emissions levels and to encourage transition into more sustainable energy sources, many governments have enacted unilateral regulations — and ratified international agreements such as the Kyoto Protocol and the Paris Agreement. These policies introduce new institutional pressures on firms' to adapt their activities to meet national emission targets. Firms react differently to increased regulations (Berry et al., 2021). Some firms innovate and adapt production processes, even though such innovation comes at an increased cost (Berman & Bui, 2001). Other firms shift production abroad to countries with lax regulations (Cole & Elliott, 2005) taking away jobs, income taxes, and investments from the country. As a result, analysts and policymakers have called for restraint on introducing emissions reduction regulations and accelerated investments in renewables. For instance, on 1 June 2017, then US president Donald Trump announced the withdrawal of the US from the Paris Agreement, citing the "unfair economic burden imposed on American workers, businesses, and taxpayers" (Pompeo, 2019).

Yet, there is sparse evidence about the impact of countries' environmental policies on multinational firms' investments. This paper is concerned with the association between countries' efforts to reduce emissions and firms' investments.

We analyze foreign investments by 882 US multinational firms in 102 countries that signed the Kyoto Protocol- an international UN treaty to reduce greenhouse gas emissions- in period 2000-2015. We find that countries that signed the treaty reduced emission levels and increased reliance on renewables. Furthermore, policies to reduce greenhouse gas emissions do not have an effect on the level of foreign investments received, while policies aimed at encouraging the transition to renewables, lead to more investment from foreign firms.

One important implication for policymakers is that fear of losing foreign investments to countries with lax emission regulations need not deter them from adopting policies to achieve greater environmental sustainability. You can read the full study <a href="here">here</a>.

# **Emerging Markets and Rise of Asia**

#### Theme

The cluster's research advances our understanding of the economic integration of large and rapidly growing emerging markets into the global economy. From a policy perspective, this includes work on state-business relationships, industrial and innovation policies, skill upgrading, as well as educational reform. From an international business perspective the cluster investigates firms' non-market strategies, foreign direct investment, global value chain dynamics as well as issues of cross-cultural management. The future research will also address two new themes: The first relates to geopolitical and geoeconomic developments, such as the tensions between the US and China, the reservations towards Chinese technology and social media companies, or the Chinese Belt-and-Road Initiative and corresponding implications for international business and economic policy within Asia, the EU, or Denmark. The second theme relates to the impact of COVID-19 and the economic recovery process in emerging markets.

#### Seminars, workshops and lecture series

In May 2022, the cluster invited Prof. Frank Pieke to EGB to give a guest lecture on "CCP Party Building Outside of China and Impact in Europe". In his lecture, Prof. Pieke investigated China's presence abroad from the perspective of the Chinese Communist Party.

In September 2022 the cluster hosted Bruce McKern, University of Technology Sydney, to conduct a talk on "China's technological capacity".

In November 2022 Prof. Tomoko Kawakami of Waseda Business School gave the seminar "Does national culture affect AI adoption?"

The cluster participated in and contributed to workshops in the Asia Research Community (ARC), providing an Asia-related research platform across CBS departments. The annual ARC Research Workshop in December 2022 focused on Vietnam as well as a session on work-in-progress. Participants: Fulbright University (VN), University of Gothenburg (SE), Stichting University (BE) and CBS (IOA & EGB).

The Sasakawa Foundation has funded a lecture series on "Japan in the current world order" lecture series with prominent scholars and officials from Japan and the USA. The lecture series, arranged in cooperation with the Danish Foreign Policy Association starts out in the spring 2023, and will take a closer look at Japan's relations to China, the USA, the EU, the ASEAN as well as the domestics conditions of Japanese foreign policy.

Peter Gammeltoft visited Northeastern University and participated in a jointly organized conference in Vancouver as part of the project "International Network Programme"; a 2022-2023 grant for an emerging markets network with Northeastern University, Cornell University, and University of Texas.

#### **Grant activity**

In 2022, cluster members became coordinators of the 30 million DKK EU Horizon project, "Dealing with a resurgent China" (DWARC), Nov. 2022 – Nov. 2025. DWARC aims to create connections between European knowledge nodes in China and to create an enduring collaborative network. The key subjects to be covered include society and culture, politics, economy, and foreign policy. EGB will be responsible for coordination as well as leading the work package on politics.

The Danida-funded research project: "Innovating Vietnam's technical and vocational education and training (TVET) system for sustainable growth", July 2020-December 2022. The project aims to identify potential upgrading targets for Vietnam's export industries; assess the gap between the existing skills/capabilities in the Vietnamese work force and the skills/capabilities required to manufacture the target products; and discuss necessary curriculum reforms and partnership models for Vietnam's TVET sector.

The project "EU's Free Trade Agreements with Asia" is motivated by the several new bilateral FTAs between the EU and South Korea, Vietnam, and Japan that were promulgated during the past decade. They project explores the question: "What determines the use of the trade preferences offered by the FTA?"

The research project "Special Economic Zones - A force for good to reduce Inequality?" examines the consequences of SEZs in Ghana, India, and Vietnam. In collaboration with researchers from Germany, India, Ghana, and Vietnam, the participants from EGB study employment generation, income differences, gender equality, and other effects of these special institutional arrangements.

Throughout 2022, a group at CBS worked with Indonesians partners on a proposal for Danida on governance and green transition in the Indonesian energy sector. In January 2023, the project was approved and granted 10 million DKK.

#### **Public outreach**

The cluster has continued its dialog and interactions with Danish-Chinese Business Forum and Dansk Erhverv in 2022. Kjeld Erik Brødsgaard spoke in DCBF's annual signature event "China Outlook – Political, Economic and Business Update", and took part in a DCBF-Danske Bank event evaluating the CCP's 20<sup>th</sup> Party Congress. In addition, members of our cluster have throughout 2022 engaged actively with Danish and foreign media outlets, e.g. on the topics of state-market relations in China, economic decoupling, the 20<sup>th</sup> Party Congress and the Taiwan issue etc.

In line with an increased Danish government focus on Indonesia and Southeast Asia, a group including Aarhus University, DTU, CBS, Siemens Denmark, and the embassy in Jakarta has been discussing ways of expanding research and teaching collaboration between Denmark and Indonesia. Peter Gammeltoft and Björn Jindra have participated in the group. Björn Jindra participated in a delegation trip to Indonesia in September with the purpose of establishing agreements with Indonesian universities.

# **Teaching**

September 14-16 2022, Bent Petersen co-coordinated and taught a 3-day Nord-IB course, "International Business in an Emerging Markets Context" - see https://www.nord-ib.fek.uu.se/. In addition to Bent Petersen, the faculty also included Peter Gammeltoft and Ari Kokko from EGB.

Bent Petersen has written a teaching case, "Maersk's Non-Market Strategy towards State-Owned Chinese Rivals". The case is co-authored with EGB-colleague Toshimitsu Ueta and published by Ivey Publishing (product number W25258).

Throughout 2022, members of the research cluster at EGB continued their teaching contributions to the Master's program in Public Management & Social Development at the Sino-Danish Center, as well as the International Business in Asia program at CBS.

In 2022, the cluster hosted Pengqi Liu, a PhD student from the SDC partner university, UCAS.

The cluster has also hosted two PhD students from Beijing Jiaotong University.

Furthermore, the cluster hosted Saken Kazhenov, a Bocconi PhD-student, doing work on incubation in Kazakhstan, which also feeds into the societal challenge theme of "Technological change and digital transformation".

# Example of public outreach: Innovating Vietnam's TVET system for sustainable growth (VIETSKILL)

VIETSKILL is a Danida-funded research project carried out by EGB in collaboration with Nha Trang University in Vietnam. The project will be completed in June 2023. It aims to identify measures to strengthen the system for technical and vocational education and training (TVET) in Vietnam to promote labor productivity growth. Currently, Vietnam's labor productivity is among the lowest in East Asia. Many of the foreign investors that have entered the economy over the past two decades complain that weak labor skills make it difficult to find competent local sub-contractors and to upgrade the local value added in their exports. At the same time, few domestic firms have the skills and capabilities needed to export high-value industrial products on their own, and most struggle to enter global value chains (GVCs) as suppliers and sub-contractors to the foreign MNEs in the country. Investments in human capital (particularly technical and vocational skills) are needed to raise labor productivity, strengthen the links between local firms and foreign MNEs, and upgrade the country's position in global value chains.

The key research questions addressed by VIETSKILL are: i) What are the necessary skills and capabilities needed to meet the demand from foreign MNEs and to gain access to GVCs in the electronics and food processing value chains? ii) How successful is the current TVET system in delivering these skills and capabilities? iii) How can the performance of the TVET system be strengthened?

In November 2022, the VIETSKILL team arranged two seminars/workshops in Bac Ninh and Nha Trang to discuss research findings and to collect feedback from stakeholders (enterprises, public sector agencies, training institutes) related to the electronics and food processing industries. More than 50 participants attended the seminar in Bac Ninh on November 1, which discussed research and stakeholder views on the current state of labor skills, professional skill training investments by enterprises, and cooperation between enterprises and training institutes. A well-attended follow-up seminar focusing on the food processing sector was organized at Nha Trang University the following week (November 10). After a summary of research findings, seminar participants shared their experiences and proposed models for cooperation between training institutes and businesses. Both seminars were well covered by Vietnamese media, including reports on the prime-time evening news of VTV1, the main state-owned news channel.

# Business, global shifts and policy challenges

#### **Participants**

The cluster has a core consisting of Mads Dagnis Jensen, Bent Petersen, Torben Juul Andersen, Eddie Ashbee but other members of EGB have also been involved in our seminars, workshops and discussions.

#### **Theme**

The cluster considers (a) the extent to which the globalizing processes of recent decades have now slowed or are taking a different form (b) the consequences for governments, policymaking processes and markets and (c) the impact of this upon firms and the strategies that they can pursue. In doing this the cluster seeks to bring the study of business and politics together in ways that are both multidisciplinary and interdisciplinary in character.

# Example of workshop: Decoupling and deglobalization. The state of the debate

Presentations by Peter Ping Li, Bent Petersen and Eddie Ashbee. September 29<sup>th</sup> 2022:

This well-attended workshop considered the character of contemporary "decoupling" processes. It established a framework that will be pursued in 2023 (see below) and began a dialogue around core issues. The papers that were presented assessed the impact of increased risk and the growing fragility of supply chains. Within this context they considered the degree to which offshoring by firms was increasingly being supplanted by "friend-shoring", the efforts of different governments to assert sovereignty over data flows, and the ways in which successive crises were leading governments towards the pursuit of industrial policy, changing trading relationships, and more intensified forms of rivalry.

#### **Future activities**

The cluster is now working towards a workshop (Business and the challenge of neo-nationalism) involving EGB, colleagues from other CBS departments as well as other universities. As the Call for Papers notes:

"Both businesses and governments have faced successive and concurrent shocks in recent years. These have included the financial crisis, the migrant and refugee emergencies, trade tensions, the Covid-19 pandemic, war, heightened security fears, and the fragility of supply chains and energy supplies. Whilst this sometimes takes a hidden or subterranean form, governments have increasingly embraced neo-nationalist strategies based upon a renewed commitment to industrial policy through subsidies, legally-directed forms of sourcing and production requirements, changes to the tax regime, and protectionism. Alongside these moves, further barriers to market entry have been imposed and there have been increasing de jure and de facto controls upon labour mobility. At times, there have been conscious efforts to facilitate "decoupling". Despite the efforts of the Biden administration to distance itself from its abrasive, populist and mercurial

predecessor, and the collective rallying around Ukraine, established forms of international cooperation appear to be in jeopardy."

The workshop will consider the impact of these shifts at three levels: for firms, across sectoral markets and in terms of government and governance. It is intended to lay a basis for an edited collection or special issue and preliminary discussions have already been held with publishers and editors.

## Example of grant: Risky Business: Managing in a world with extreme exposures

#### Independent Research Fund Denmark/Danmarks Frie Forskningsfond #8019-00046B

The project *Risky Business*, also the title of a (famed) Tom Cruise movie (1983), is supported by the Independent Research Fund Denmark (2019-2022). It explores how to manage in a world with extreme exposures. As the movie hints, risks also present opportunities, but we know too little about how firms can generate and exploit them. The research project was inspired by regularly observed fat-tailed distributions of financial returns across firms, where many underperform and few excel, and aimed to understand how some firms adapt to extreme exposures and consistently outperform.

The project collected extensive datasets comprised by European and North American firms over the 25-year period 1995-2019 that spans economic scenarios of global expansion, recession, and recovery up until the Covid-19 crisis in 2020. Analyses of both datasets consistently find extreme left-skewed performance distributions with small positive tails of high-performers across different geographies, industries, and time intervals. Subsequent refined analyses of complete datasets show how left-skewed returns are associated with negative risk-return relations, where high-performers generate superior average returns at lower variation in returns. We further show that unfavorable risk-return outcomes relate to overconfident executives whereas high performers retain investment flexibility. These results resonate with propositions linked to interactive decision-making processes where executives use frequent operating insights to update ongoing strategy deliberations. We model this approach and use computational simulations to show how it produces the empirically observed negatively skewed performance distributions and inverse risk-return relationships. Finally, we analyze subsamples of extreme negative and positive outliers to uncover the characteristics of these low and high performing firms.

Firms face dynamic complex contexts where extreme events are difficult to foresee. Leaders often respond by adopting control-based risk management practices in a belief they will contain the uncertainty. That is a fallacy. The studies indicate that interactive collaborative decision-making drives effective adaptation to extreme exposures.
