#### **Profile**

Carsten Greve is Professor of Public Management and Public Governance at the Department of Organizations, Copenhagen Business School. He has just finished being Academic Director of the CBS Public-Private Platform, an outreach initiative supported by the CBS board for the period 2011-2016. He has been full professor since 2010 and he was professor with special responsibilities from 2006-2010. He received his master's degree in political science (cand.scient.pol.) in 1992 from the University of Copenhagen, and earned his Ph.D. in political science in 1997 from the University of Copenhagen (PhD thesis on state owned enterprises).

Carsten Greve has been at CBS since 2004. He was at the Department of Business and Politics and is now at the Department of Organization. From 1998-2004 he was at the Department of Political Science, University of Copenhagen. In 1996-1997, he was at the Institute of Economics, Politics and Public Administration in Aalborg University in Denmark.

Carsten Greve's main research areas are public-private partnerships and public management reform from an international perspective, including leading partnerships, contracting, privatization, corporatization, regulatory reform and governance. Carsten Greve has published in international journals such as Public Administration Review, Governance, Public Administration, International Public Management Review and Public Management Review. Together with professor Graeme Hodge, Monash University, he has published several books on public-private partnerships and with Niels Ejersbo several books on public management reform. Carsten Greve's current research interests focus on the governance and management of public-private partnerships and management reforms in a comparative perspective. He has been an advisor to the Danish Ministry of Finance, the Danish National Audit Office and the Danish Productivity Commission and the Danish Ministry of Education. He was chair of the CEMS Interfaculty Group on Public Management and Governance, a pan-European research and teaching group. His current research projects include the SUSTAIN project on sustainable national transport planning, (with DTU), financed by the Danish Strategic Research Council with 13,4 mio DKK (ending March 2017).

Carsten Greve was the first academic study director of the new flexible executive Master of Public Governance executive education program that Copenhagen Business School is offering together with the University of Copenhagen, a program with 600+ public managers enrolled. His teaching is centered on courses on public management and governance. He has supervised 4 PhD projects in the last three years. He is under contract to write a book on "The Logic of PPPs" for Edward Elgar (with Graeme Hodge) and published a volume in 2016 on Nordic public administrative reforms for PalgraveMacMillan
